

## The economy of tomorrow: a green economy decarbonized, circular and regenerative

The economy of tomorrow will be a green economy: decarbonized, circular and regenerative.

It will be decarbonized because prosperity can no longer be generated without addressing the climate crisis; it will be circular because development can only be ensured by reducing the consumption of materials that have become scarce; and it will be regenerative because, in order to continue to have indispensable ecosystem services, it will have to avoid the dissipation of natural capital.

The transition to tomorrow's economy requires challenging innovation and substantial investment, the ability to capture its economic benefits, attention to cost management, care for social inclusion, employment and the most exposed economic sectors. Stopping, slowing down, falling behind in the transition to tomorrow's economy would still be the worst option: with the highest economic and social costs.
